The petition must be signed by not less than fifteen percent (15%) of the number of ballots counted in the previous year's election with not more than 10% or 15% (whichever is greater), of eligible voter signatures per company. The petition shall be filed with the Nominating Committee Chairman at least three (3) weeks prior to the election and shall deliver notice of such additional nominations to all members eligible to vote at least two (2) weeks before the election.

Voting will begin Tuesday, June 13, 2017 and will conclude on June 27, 2017 at 4:00 PM. **Voting will be conducted ONLINE** and a link will direct you to the site where you will cast your vote.

**PLEASE NOTE: According to the Bylaws, no more than four (4) Directors and/or Officers from a firm, partnership or independently owned office may serve on the Board of Directors at the same time.**
